

Girls' Voices at Home "Thank Your Teacher" Contest 2020

Contest Participation Agreement

RULES AND REQUIREMENTS
A PURCHASE IS NOT NECESSARY TO ENTER THIS CONTEST
WINNERS TO BE CHOSEN ON MERIT – THIS IS NOT A SWEEPSTAKES OR LOTTERY

DATES OF CONTEST:

Contest opens on May 4, 2020 at 12:00 a.m. Pacific Standard Time (PST) and closes on May 24, 2020 at 11:59 PM PST (the "Contest Period"). The submission period will begin on May 4, 2020 at 12:00 a.m. PST and Contestants must submit all entries no later than 11:59 PM on May 24, 2020, PST.

ELIGIBILITY:

Girls' Voices ("GV") is a program of GreaterGood.org ("GGO"), a 501(c)3 non-profit, public charity registered in the State of Washington with its principal offices located at One Union Square, 600 University Street, Suite 1000, Seattle, WA 98101. By entering you agree that this Contest will be subject to and governed by the laws of the State of Washington, USA. This Contest is being conducted by GGO. No GGO employees and personal associates, families (including those with whom they reside), GGO directors, officers, representatives and agents of GGO may enter or participate as contestants.

All participants ("Entrants") submitting an entry ("Submission" or "Project") to the Contest must meet the following criteria:

- 1. Projects must have been created between May 4, 2020 and May 24, 2020.
- To be eligible, Entrants must be between 13 and 24 years of age as of May 4, 2020 and be enrolled in school. Documentation showing school enrollment may be requested. Documentation showing current employment of nominated teacher at an educational institution or program may be requested. Teacher nominations must be made at the time of entry.
- 3. Nominated teachers cannot be relatives of the Entrant.
- 4. Minor Entrants (those younger than 18 or the age of majority in their country, whichever is greater) must have parental approval.
- 5. Length of all submitted videos must be less than 4 minutes in length. All Submissions must be made through the Girls' Voices at Home Website (the "Contest Site").
- 6. All Submissions must be the Entrant's own ideas and imagery.
- 7. Entrants cannot include photos, video clips or music created by others without the written permission of the underlying copyright owner.
- 8. If the submitted Project contains images of other people, the Entrant must provide a written release from those shown in the Submission. The release must name both the Entrant and GGO, providing consent for use in the Project and by GGO, subsequently, under the terms of the Contest rules.



- 9. Parents or guardians may submit media on behalf of the Entrant.
- 10. GGO staff may provide feedback, editing support, and translation at any time during the submission process.
- 11. All work must be submitted online in digital format.
- 12. If the Project is not in English, please submit the Project with English subtitles.
- 13. Projects must follow Girls' Voices community guidelines, and must not be violent, show illegal activity, contain bad language, or be negatively directed at a group of people.
- 14. GGO is not responsible for any improperly submitted, technically un-viewable, lost, incomplete, late, or damaged Project entries.
- 15. The Entrant Winner will be required to complete and agree to all terms of GGO prize acceptance form before being eligible for the grant awards.
- 16. Nominated teacher Winner will be required to complete and agree to all terms of GGO prize acceptance form before being eligible for the award.
- 17. Any prize won by a minor Entrant shall be accepted on their behalf by the Entrant's parent or guardian.
- 18. Participants can submit more than one video, but only the first submission will be eligible.

CREATIVE GUIDELINES:

Entrants must submit a video that answers the following prompt:

"Who is the teacher who has inspired you the most and why?"

The Entrant's nominated teacher may (may not) appear in the video.

The teacher's name must be mentioned in the entry submission video.

HOW TO ENTER:

- (1) Visit The Contest Site located at www.girlsvoicesathome.org
- (2) Registration: Complete the official Contest online registration form (the "Registration Form") in its entirety including email, first name, last name, location, age, parent/guardian email (where relevant), nominated teacher name, school name, teacher email, and teacher phone number.
- (3) Record and submit video that follows the provided prompt. Verify age and parental consent, or entries will be denied.

Submissions will be rejected if the required fields of the Entry Form (labeled with *) are not fully completed and submitted during the Contest Period. Use of any automated system to enter is prohibited and will automatically result in disqualification.

GGO is not responsible for lost, late, mutilated, or incomplete Submissions. GGO has no obligation to acknowledge receipt of or to return any Submissions received.

By submitting an Entry Form and other required submission materials, the Entrant or the Entrant's Parent or Guardian, on behalf of the minor Entrant: (i) warrants and represents that he/she has read these Official Contest Rules or has had these Rules translated for them into the Entrant's first language, is eligible to participate in the Contest and agrees to be bound thereby; (ii) warrants and represents that all of the information provided in his/her Submission materials



is accurate; (iii) that if the Entrant is less than 18 years of age or less than the age of majority in the Entrant's Country of Citizenship (whichever is greater) the Entrant's Parent or Guardian hereby consents to the Entrant's participation in the Contest, and (iv) consents to the use of his/her name and/or likeness by GGO and its respective authorized representatives for promotional purposes in connection with the Contest (whether online, in print or through any other media now known or hereafter developed), without additional compensation and unless prohibited by law; and (iv) agrees that, if selected as the winner, Entrant will be solely responsible for any and all resulting tax consequences.

Entrants' chances of being a Winner are dependent on their adherence to the Rules and the Judges' determination of the artistic, technical quality, and relevance of the submitted Project. This is not a sweepstakes where your odds of winning are determined solely by the overall number of Entrants nor is the Contest a lottery where winners are chosen at random. This is an artistic and grant submission opportunity, with the results determined by artistic and social impact appraisal of your submission as described in these Rules. By participating in this Contest, Entrants waive any right to challenge the results, decisions by the Judges or the process described herein. Entrants agree to release and hold harmless GGO and its directors, officers, employees, agents, and licensees, and agree to abide by all decisions of GGO.

Each Entrant retains copyright ownership over their Project, to the extent any such rights exist in their name at the time of submission. However, in exchange for the opportunity to participate in this Contest, each Entrant and all others associated in the creation of the Submission(s) grants to GGO a perpetual, non-exclusive, royalty-free, worldwide, and irrevocable right to use, edit, alter, copy, reproduce, disclose, display, publish, prepare derivative works from, perform, distribute, exhibit, broadcast, or otherwise exploit the Project(s), including photos, in whole or in part, in connection with the Contest and/or as, in GGO's sole discretion, any other GGOrelated business use by means of any form, media or technology now known or hereafter developed, including, but not limited to, broadcast and cable television, radio, mobile transmission, and the Internet, for any purpose whatsoever, including, but not limited to, advertising, promotion, entertainment and commercial purposes, without any payment to, or further authorization by, the entrant. Without limiting the foregoing, each Entrant consents to have the Entrant's Project, including photos, made available for public viewing and/or comment and/or rating and/or voting on the Internet. Entrants acknowledge and agree that GGO may require, in its sole discretion, the execution of a more specific Grant of License for materials submitted. Entrants cannot later withdraw a Project or this Grant of License once submitted. Nothing in this Agreement obligates the GreaterGood.org to make any use of any submitted Project. GGO reserves the right to take down a submitted Project from the Girls' Voices at Home website, or to elect to not exhibit or promote any particular submitted Project, or Entrant, even if the Entrant is a finalist or winner. Some States may limit the length of the license term making residents ineligible to enter.

GGO reserves the right to terminate the Contest, amend Contest Rules or change Contest Rules at any time without prior notice. Any Entrant in the Contest shall have no legal recourse against GGO, its agents, assigns, advertising agency and consultants and their respective employees for any such changes, cancellation or termination.



These Contest Rules, in combination with any shown on the Contest website, constitute the entire agreement between the Entrant and GGO regarding any and all participation and supersede any other written or oral communications you may have with anyone, including any phone calls to our staff. This Entrant Participation Agreement shall be governed by the laws of the State of Washington, USA.

SELECTION AND WINNER:

From the close of the submission period to May 27, 2020, a panel of judges from GreaterGood.org shall select one (1) winner. The winner shall be judged on adherence to the Contest's submission description and requirements. The winner will be announced on May 28, 2020.

PRIZES - AWARDING:

One (1) Winner will be chosen.

No transfer or substitution of prize is allowed except at the sole discretion of GGO due to prize unavailability for any reason and only then for a prize of equal or greater value.

PRIZES AND DONATIONS - TYPES:

Winner will receive one (1) \$100 Visa gift card, and their nominated teacher will receive one (1) \$1,000 cash prize.

PRIZE REDEMPTION:

By email/ phone:

All eligible Winners will be contacted by GGO at the end of the contest. The Prize may be forfeited by an eligible Winner if that eligible Winner cannot be contacted within seventy-two (72) hours after the Contest draw. Odds of winning prizes do not depend on the total number of eligible entries received during the Contest Period. None of the prizes awarded may be substituted and are not transferable. The award made to a minor Entrant shall be accepted on their behalf by the Entrant's parent or guardian. The award made to the nominated teacher shall be made directly to the teacher.

GENERAL CONDITIONS:

If the identity of an on-line Entrant is disputed, the authorized account holder of the e-mail address submitted at the time of entry will be deemed to be the Entrant. The individual assigned to the e-mail address for the domain associated with the submitted e-mail address is considered the authorized account holder. A selected Entrant may be required to provide proof that he/she is the authorized account holder of the e-mail address associated with the selected entry. The sole determinant of time for the purposes of receipt of a valid entry or vote in this Contest will be the Contest server machine(s).

By participating in the Contest, the Entrant shall consent to GGO obtaining the personal information contained in the Entry form. GGO holds the right to terminate the Contest, amend Contest rules or change Contest rules at any time without prior notice. Any Entrant in the Contest shall have no legal recourse against GGO, and its agents, assigns, advertising agency and consultants and their respective employees for any such changes, cancellation or termination.



All decisions with respect to the administration of the Contest shall be made by representatives of GGO and such decisions will be final and binding. The Contest shall be governed in accordance with Washington law, excluding all conflict of law rules. All information submitted in connection with this Contest will be treated in accordance with all applicable GGO Official Contest Rules and GreaterGood.org's Privacy Policy.

LIABILITY RELEASE:

Entrants agree to release, discharge, indemnify and hold harmless GGO and Contest Entities and each of their respective officers, directors, employees, representatives and agents (the "Indemnified Parties") from and against any claims made by Winners, Entrants, or any other third parties, related in any way to the operation of this Contest as well as any other claims, damages or liability due to any injuries, damages or losses to any person (including death) or property of any kind resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any prize and/or participation in any Contest-related activity or participation in this Contest. Failure to return the completed Declaration and Release Forms within the time stipulated will result in disqualification and another Project entry will be selected from the remaining eligible Project entries.
